Transcripts and student records cannot be released until a student withdrawal form is completed and returned. Also, the financial policy of the school is that report cards and a transfer of records will not be released for any student with an unpaid account and/or fees.

STATEMENT OF PHILOSOPHY

PURPOSE STATEMENT

HOPE SPRINGS Christian Learning Center seeks to provide an optimum learning experience in a distinctly Christian setting for children with learning differences.

HOPE SPRINGS CLC is specifically designed to meet the needs of children who:

1. are experiencing failure in the traditional classroom.
2. have been diagnosed as being either slow learners or having a learning disability.
3. need a period of academic success and intensive training to prepare them for a later return to traditional education.
4. have parents who are committed to participate in their child's educational experience.

The key factors that make it possible for HOPE SPRINGS CLC to provide this optimum learning experience are:

1. a faculty of highly trained Christian teachers committed to helping children reach their full potential.
2. an academic program integrated with the most effective learning methods and materials available.
3. small classes of ability-grouped children.
4. one to one educational therapy following the NILD (National Institute of Learning Development) program.
5. many NILD techniques integrated daily into the classroom.

GOALS

- To remediate deficient academic skills and stimulate the areas of weakness in perception and cognition through the NILD program.
- To assist in the building of a strong Christian character by adding to the student's understanding of Biblical Christianity; the development of a personal faith, moral excellence, knowledge, self-control, perseverance, godliness, brotherly kindness and love, through:
 - carefully maintained habits
 - watching those who model this kind of life
 - parent education
 - service to the community
- To provide a safe, trusting structured environment in which the student will understand through experience that he/she can learn.
- To emphasize the knowledge, skills, values, attitudes, and behavior that will enable effective participation in the student's world as they reach for their God-given potential.
- To train them to become independent learners by fostering a positive attitude toward becoming an active learner, by teaching good study habits, by being committed to self-discipline and working through the curriculum.
- To enable students to return to the regular classroom (probably with continued NILD therapy for sometime), when it is appropriate for their best interest.



CURRICULUM

This curriculum has been developed believing that exceptional children from Christian families are a vital part of God’s creative plan when He said, “It was very good”. The scriptures teach, “As we have therefore opportunity, let us do good unto all men, especially unto them who are of the household of faith”. Exceptional children are a part of God’s eternal purpose as they are educated and bring glory to God.

Believing that being in graded classes has hindered the learning process of those with learning differences, these students will be taught in ability-level groups. When necessary, part-time teachers will be hired to teach specific subjects.

We believe that learning disabled children need not only to be in a different learning environment from the traditional classroom, but that they also need a curriculum that is sensory-based, experiential and one that emphasizes the processing of language in many different avenues.

Therefore, HOPE SPRINGS CLC will incorporate ideas from the following curriculums, but is not limited to:

- ❑ Merrill math supplemental
- ❑ NILD approach is used with the basic skills of reading, writing and spelling
- ❑ Enrichment days – conducted with the help of parents during activities such as: field trips, special speakers, special activity days
- ❑ Abeka – used for math, English, reading, poetry, history, and science
- ❑ Bob Jones – Biblical truths
- ❑ Konos – uses themes of biblical character traits along with the basic curriculum
- ❑ Core Knowledge – emphasizes literary and historical concepts in reading
- ❑ Charlotte Mason – liberal arts and sciences approached with no division between secular and religious knowledge; lots of reading with an emphasis on good literature and history



ADMISSIONS POLICIES

1. HOPE SPRINGS Christian Learning Center admits students of any race, color, national or ethnic origin.
2. At least one parent must be willing to sign the doctrinal statement and the parental agreement form.
3. The school reserves the right to deny admission to a child if his/her disability, behavior or emotional development indicate that he/she could not be best served by our school program.
4. The application should be accompanied by, a \$50.00 non-refundable service fee, current copy (not over 2 years old) of prior psychological testing*, copies of all prior school records, and a referral from a psychologist or doctor, if available.
5. Admission to HOPE SPRINGS Christian Learning Center will be determined after all admission requirements are met, including an interview of the applying family with the Admissions Committee. Notice of acceptance or non-acceptance will follow the interview session by mail or phone call.
6. Admission will be final when the school receives all fees due, including tuition payment, and the signed Doctrinal Statement and Parental Agreement forms. Payment for one year's tuition can be paid in advance, or the first monthly payment along with a signed copy of a loan agreement for the balance of the year's tuition.
7. Certification of Immunization (Form 3231) for all incoming students should be submitted before the first day of the student's arrival for the school year. This form can be obtained either from your doctor or the County Health Department. Students entering 6th grade must have a measles, mumps, rubella (MMR) booster before school starts.

* If no current testing for learning differences is available for perusing and analysis, testing will need to be arranged through HOPE SPRINGS Christian Learning Center.

PROGRAM POLICIES

- A. The HOPE SPRINGS Christian Learning Center serves students from ages 7 to 14 years of age.
- B. Instructional classes range in size from 3 to 5 students per classroom or as the director deems necessary.
- C. Classes are organized according to ability-level keeping grade level and age as part of the deciding factor. Whether placed for ability or grade level, the child will receive appropriate working skill level instruction. Class placement will be determined by the administrator, but skill and maturity levels will be a factor in the placement of the student.
- D. During the academic year, therapy consists of a minimum of 60 one-to-one sessions generally two times per week for 55 minutes each depending on holidays and inclement weather. This is supplemented by three Rhythmic Writing practice sessions each week (10 to 15 minutes each) under the supervision of a therapist or trained therapy aide. In addition many NILD therapy techniques are used in the classroom throughout the day. All students enrolled in HOPE SPRINGS CLC receive NILD therapy. Therapy sessions are scheduled during study hall and after school.
- E. Students must show evidence that they are covered by accident insurance.
- F. Parents are expected to attend all Parent Meetings and conferences. General information about learning disabilities and the policies of HOPE SPRINGS CLC, as well as important announcements will be presented at these meetings.
- G. HOPE SPRINGS Christian Learning Center takes no responsibility for providing meals or transportation. A list of the names and addresses of parents is available in the HOPE SPRINGS CLC office so parents who are interested may arrange a car pool.

Payment receipts will be separated into tuition and therapy portions, when requested by the family for insurance purposes.

Scholarship Payment Plan

(SB10) Georgia Special Needs Scholarship Program and Pay It Forward Programs

Parents are responsible to make all payments on time. If a scholarship payment is expected but not received by payment due date, parents will be expected to make the current payment and scholarship payment will be put toward the next month's payment.

1. **SB10** GA Scholarship payments are received quarterly. All fees are due at time of enrollment. If scholarship does not pay 100% of tuition, the scholarship amount is deducted from tuition due and then only the monthly payment plan above will be chosen for payment of balance. Payments are due the 10th of each month.
 Sample: \$9,240.00 plus interest minus scholarship value (4 payments) divided by 10 months
2. **Pay It Forward (PIF)** All fees are due at time of enrollment. Payments are due the 10th of each month. *NOTE: Due to new regulations, all PIF monies received January through April will be deducted from May's tuition payment. PIF monies received during and after May will be credited to the next year's tuition.

Scholarship Payment Plan

Pay It Forward/Corporate Giving for Education or other SSO Georgia Scholarship Program

Deduct the SSO scholarship amount from tuition due and then check a payment plan on the Parental Contract for payment of balance. All fees are due at time of enrollment.

Sample: \$4,300.00 plus interest minus scholarship value divided by 10 months
 $\$4,300.00 + \$215.00 = \$4,515.00 - \$2,500.00 = \$2015.00/10 = \201.50 (due the 10th of each month)



Supplemental Funding Participation

The founders and the members of the Board of Directors of HOPE SPRINGS CLC had a vision to establish a school that would provide a revolutionary new approach to helping children with learning disabilities, and to make it as affordable as possible for the average Christian family. To accomplish this they employed qualified NILD educational therapists to do both the therapy and the classroom instruction. With a very low student to teacher ratio, this has proven to be very expensive. It is important that everyone involved with HOPE SPRINGS CLC recognize that tuition payments and fees cannot cover the operational expenses of the school. To offset the expenses of the school not covered by tuition and fees, Hope Springs has two fund-raisers each year. Each family is required to participate in these fundraising activities. Generous contributions are also necessary.

- A. HOPE SPRINGS Christian Learning Center provides each year a learning experience through approximately a week-long school trip. Each student plus a parent or adult chaperone are expected to attend. The cost usually ranges between \$600.00 - \$1,000 per person depending on the expenses of the trip planned.
- B. HOPE SPRINGS Christian Learning Center also has an annual Golf Classic in the spring of each year in which all parents are expected to participate by generating a minimum of \$500.00 in prizes or donations and two foursomes of golfers. If they are unable to participate, they will be responsible to personally donate the equivalent amount.

After expenses are paid, proceeds from these fund-raisers are used by Hope Springs CLC for operating costs, advancement of teacher/therapist education, and other materials or services deemed necessary for the improvement of the school.

Proceeds from the school trip and any donations for the Golf Classic can be deducted on your income taxes as a donation to a non-profit organization. You will receive a tax form from the bookkeeper declaring the amount donated.
